A recent Needs Assessment and Market Study highlighted disturbing statistics around the issue of Affordable Housing in Henderson County. **The League of Women Voters and Affordable Housing Coalition are teaming up** to "shed some light" on this subject in a **Public Forum** Thursday, March 17, 2011. We will gain a deeper understanding of how a lack of adequate "workforce" housing affects everyone living in the county.

The forum focus is a subject dear to League. Included in the long history of League's positions and advocacy for affordable housing, their participation in a HUD project in 1979 enabled local Leagues to promote the entry of women into the mortgage credit market and sparked interest in the problems of single-headed households, displaced homemakers and discrimination against families with children. Passage of the Fair Housing Amendments was a priority for League in 1980; they supported reauthorization of the Home Mortgage Disclosure Act in 1982. From 1989 to 1990, the League advocated for the enforcement of the Fair Housing Amendments Act, endorsed recommendations to Congress to create the Affordable Housing Fund for very low income families...and also urged for the protection of nonprofit organizations that provide the bulk of housing services for the same people in need.

The March 17th Forum will include the history of affordable housing in Henderson County, what is, and is not, being done, and how the public could be involved in building advocacy in this vital part of our community life.

The speakers who will each bring great insight and experience to the subject include: **Anthony Starr**, Planning

Director, HC Planning Dept., **Hoyt Bynum Jr.,** Executive Director of Habitat for Humanity, and **Patrick Kennedy**, Executive Director of the Housing Assistance Corporation. In addition, **two recipients** of affordable housing will relate their experience of navigating the process and how it has affected their lives.

How much knowledge and awareness do each of us in League actually have about the natural resource issues of Henderson County? Do we know the committed individuals and groups who are working tirelessly for protection of our resources? Do we understand that a key responsibility for Leaguers is to at least have a 'talking-point relationship' with respect to our National, State, and local positions on natural resources? We think it may be time to take some steps to fill in the gaps in our awareness and participation!

LEAGUE, ECO, AND BRCC are partnering to bring a special educational and participation opportunity to our members, to ECO members and the public...Monday evening, 6-8:30 pm at BRCC Patton 1st floor classroom #150. It's all about awareness, education and advocacy choices. When we belong to an educational organization, it's our responsibility to educate ourselves on what we are about!

Our beautiful natural resources in Henderson County are very inviting to developers and other influences of change that might be tempted to disregard the need for protection and wise management in the public interest. The commissioners and planning and zoning boards are very responsible for outcomes of requests and proposals. ECO (Environmental Conservation Organization), is a very visible, thorough, advocate of protection of the 'big picture'. In the past 46 years of service in HC, League has been involved in developing the Mountain Land Conservancy, in giving input to the Land Development Code and the Soil Erosion and Sedimentation Ordinance, and in ongoing promotion of Recycling. In the last 5 years, we have also fostered a partnership with ECO through volunteering with them. We will learn about the four main thrusts of ECO and other organizational resources we have in HC as well as what specifically can 'one person do'. It's not the size of the action, it's the collective action that gets things done. Of course, League will always continue speak to our positions as needed re: proper regulations for steep slope, storm water runoff, recycling, and the Regional Water Authority issue, to name a few. What other needs are there? Where is our energy needed? Let's get to work! Even an hour a month...a week...we can get it covered together!

LWVHC HAS APPLIED FOR A \$1000.00 GRANT TO STUDY REDISTRICTING 2011-12

GEARING UP FOR THE APRIL 21st CONSENSUS MEETING:

"Do Advisory Committees in Henderson County Promote Transparency/Democracy?"

Our General Meeting time in April is designated for discussion and exploration of consensus. Do set aside time to read the report and schedule your time April 21, 3-5 PM to attend! New members, especially, will find the **consensus process to be a unique experience.** Long-time members know that consensus is one of the pillars of League.

The **discussion questions and the executive summary** you find in this Bulletin will whet your appetite to read the **full report ready to read online** (or print if you prefer). Watch for your copy that will be arriving electronically in the next few days. While the entire copy including the Appendix is 50 pages, you may want to print only the body of the report or you may choose to read it online. For those members who are not connected electronically, hard copies will be made and delivered or mailed to you – courtesy of in-kind contributions. In either case, **come prepared to participate in the consensus process at the April 21 meeting.**

<u>Small groups of 8 – 12 will give everyone</u> an opportunity to have his/her voice heard. Facilitators will be Carolyn Schmalz, Renee Kumor, and Lee Luebbe. If there are recommendations to be made, these will be submitted in summary form together with the consensus statements – if consensus is reached. The LWVHC Board will receive the report in May and after its adoption, the final report will be published online for the general public.

To the more than twenty League members who assisted in gathering information from the surveys completed by eighteen advisory committees/boards and especially to the editors, Kathy Baluha and Mary Ann Engel, who finalized the draft form, I send sincere appreciation. You have carried out this local study, learned much about advisory committees, and, in some cases, made new friends. Now it's time to explore consensus. Reserve the date, April 21, and the time, 3-5 PM to be at the Chamber Community Room and participate. This is Civics 101 in practice!

Discussion Questions:

The following discussion guide is provided to assist members and especially facilitators in preparing for the April General Meeting. Be informed about the Freedom of Information Act, the LWVUS positions listed in Representative Government, "Citizens Right to Know"; Ethics Code of Henderson County and the Sunshine Laws of NC. For information review websites: www.lwv.org. - at this site review topics under Open Government, representative Government and an online publication, "Looking for Sunshine: Resource Guide;" www.ncopengov.org – this site is a statewide coalition of which LWVNC is a member.

If you were one of the many League members who participated in the survey work, be prepared to make comments about your observations, i.e., the surveys conducted as well as recommendations to be considered in

a consensus statement to be included in the final report. Whether consensus is reached on one or more areas will depend on whether common ground has been found after all voices participating have been heard.

Facilitators will need to pace their time to make sure all areas are covered in the time allotted.

Ground Rules will be posted so all participants present will be able to participate. Consensus does not mean unanimity. It means my voice was heard and respected -- "I can live with the position."

UPDATE ON THE ERA NC...FEBRUARY Meeting held in Black Mountain

The ERA five (Elaine Martin, Judy Dellera, Martha Sachs, Madeline Royes, Nancy Glowacki) are continuing to attend planning meetings in Black Mountain at Robbie Madden's who is spearheading this 'push'. Feb. 26th was our second ERA planning meeting joining with others to continue laying the groundwork for introducing an ERA resolution to ratify North Carolina as one of the three states needed to finish the job. We are in favor of the three-state strategy rather than the bill being introduced into Congress to 'start over'. We also support another bill that will try to dissolve the threat of terminating ratification because the time extension is theoretically up. During this work session, we laid out some specific goals and built a 'road map' to guide the completion of these goals. Specific tasks were taken up by different people to complete the first phase of research in several areas. We will **meet again April 9** to begin the next step.
