PROPOSAL FOR A MINI-STUDY AND UPDATE (TIME FRAME: Sept. thru Nov. 2011)

STATEMENT OF THE PROBLEM

The major environmental issue for Henderson County and the City of Hendersonville is the water supply and water quality. Spring arrives earlier, fall occurs later, and summer lasts longer. The South East has been experiencing severe drought and states are in conflict over water supplies. All one hundred counties of North Carolina experienced categories of drought and HC was categorized as the most severe. The City Council responded with water conservation methods approving an amendment to the City Code of Ordinances regarding water shortages and conservation methods.

The issue is the League support for the Asheville/Buncombe Henderson County Regional Water Authority which was abolished by the Court and may not be revived in the near future, unless the State mandates it. The League of Women Voters does not know the outcome of the law suit. At this time the Henderson County Commission does not have a water policy. Water resources are a regional problem because rivers, streams and creeks flow through states, counties and cities. The Mills River and the French Broad River, the source of Henderson County's water supply, originates in the Pisgah Forest in Transylvania County. The Mills River flows South and the French Broad River flows North to Ashville. The Hendersonville Henderson County Water Resource Management document states the Mills River , Bradley Creek and Cane Creek do not provide significant growth potential. (p.3). Nat Wilson, Section Chief of the Water Resources Division of DENR stated Brevard 's ground water would be depleted by 2050 and they should begin conservation methods now. The French Broad River depends upon rain water to meet the demand of many water systems as it meanders north and into Tennessee.

An initiative of the French Broad Water Resources Study Committee was proposed due to the drought to conduct a broad study of water resource issues. There is no intent to form a regional water authority, but to serve as a forum on regional water issues. The Land of Sky Regional Council formed a committee to study water resources in the region, the capacity of water systems, future water supplies, water quality conditions and other key water resource issues. A series of meetings are being held with representatives from Region B which includes Henderson County. A final report is due by the end of August 2011.

The LWVUS position on water resource management supports programs and policies regarding water quality, quantity, ground water and surface water and the potential depletion or pollution of water supplies.

The LWVHC needs to be knowledgeable about population projections, the need for housing, farmland preservation and new industries, all of which create pressure on the water supply. Therefore, this committee recommends a three-month update of our present position in support of a regional water authority.

PROGRAM OBJECTIVES (NEEDS ASSESSMENT)

Why did the Regional Water Authority Fail? What was the outcome of the law suit?

Determine the water resource needs of Henderson County. The Mills River may be unable to supply enough water for Henderson County during future severe droughts. The measurement requirements are gallons of water to supply the population, the agriculture industry and other industries. What kind of entity will be responsible for carrying out mandates? What reorganization is being devised?

METHODOLOGY- Analytical Administrative Case Study (NOTE - At present six members of the LWVHC wish to join the evaluation committee which will meet beginning in September. This entire committee will be responsible for conducting the mini-study and formulating the final conclusions and report)

The methodology which is most appropriate to this investigation is the case study.

The Case Study would have a topic focus on the water resource needs of Henderson County and the government program to implement it. A Case Study would include a case description including the facts of the case, that is, describe how the problem evolved, an analysis of the causes of the problem within the Agency. Facts include internal and external agency environments within which events developed:

- a) political and economic factors – parties, interest groups, ideologies, and economic interests,
- b) political and economic factors of Agencies internal environment, e.g. power & influence, budget constraints, agency structures, rules, role and mission,
- c) factors of agencies internal administration environment, such as, Administrative style, tone, preference and procedures,
- d) Is there a HC plan being developed to adequately preserve and protect the quantity and quality of the water supply?
- e) Has the meetings with Region B representatives produced a plan for future water conservation?
- f) What are the Land of Sky and DENR's statistical projections for growth of the population,

agriculture, economic development, and the limits of water resources?

The gathering of data will be conducted utilizing interviews with government officials and government documents and newspaper articles., e.g. Former County Commissioner Bill Moyers, Attorney Russell Burrell and Asheville Commissioner Brownie Newman and others.

CONCLUSIONS

Conclusions will include the explanation of what happened, identifying causes and effects, evaluating the actions of the Administrators, and learning from the successes and mistakes. What should be done differently? What conservation methods should be proposed based on future projections of statistical data from a number of scientific studies?

ALTERNATIVES

One alternative could be the recommendations of the present study being conducted by the Land of Sky Regional Council for Region B.

BUDGET CONSIDERATIONS

VOLUNTEER NEEDS

1. **In the office:** Hours and activities vary. Sign up to help us get mailings sent out (2 hours every 4 months). We are also looking for help processing membership and donation acknowledgements (1 hour each week) and tracking our volunteer hours (2 hours each month).

2. **Florence Preserve Management Team:** Time commitment varies from 1-2 days/year to 1-2 days/month. We have a variety of roles for volunteers to monitor, manage and maintain our Florence Nature Preserve in Gerton.
3. **Stewardship Days:** 1-4 days/month, typically in Spring and Fall. Volunteers help restore native habitat at a variety of conserved lands.

This month educates the public about the process of issue study, specifically the recently completed study on Advisory Committees in Henderson County. Issue study is **the cornerstone** of League's positions and advocacy...every member must be aware of this responsibility! May 1, 2011

The League of Women Voters has a long tradition of issue study. The process for study of an issue is designed to be thorough and unbiased. Once the study is completed the membership is brought together to develop consensus, defined as a collective opinion. The League has used this method of arriving at a position for many years. Consensus is not a simple majority, nor unanimity but a general agreement of the members present at the meeting. Minority opinion is noted but does not dictate the consensus responses. To begin the study process, the membership adopts a study issue at the annual meeting. The Henderson County LWV began a local study adopted at the 2010 Annual meeting. The study: Do Appointed Bodies in Henderson County Encourage Citizen Participation/Democracy.

The Henderson County LWV began a local study adopted at the 2010 Annual meeting. The study: Do Appointed Bodies in Henderson County Encourage Citizen Participation/Democracy. Based on LWV process of study and consensus, our local League appointed a study committee who designed the depth of the study and a timeline to meet the study objectives. The study committee presented a timeline and path to research the topic. One of the objectives of a local study is to recruit and involve old and new members in process. The study committee recruited many members who were interested in the topic, pulling especially from our Observer Corps, those members who attend local government public meetings regularly. The participants helped the committee work out the details and volunteered to help conduct surveys.
